7. COMMUNICATIONS

Bird talked about the following items:

A. Updates on Active Town Projects

Bird mentioned that the Cleveland Avenue Construction Project is currently in the design phase and asks the group to continue to participate in public engagements. This is a CDOT project that the Town gets to participate in.

The Town has hired Matrix Design Group Inc. to do a housing affordability study. They have done a multitude of these before. Kickoff is August 6th. There will be a committee once things get a little further and will be looking for at least one Planning Commissioner to sit on the committee when it is time.

The Town has undertaken a water source development plan and is working with WestWater Research. They are looking at other sources of water as the Town currently only has one. Bird has been working with Larimer County on an IGA for the Growth Management area. There are a couple of Master Plans in the works. Bird is working with the Parks & Recreation Department on a Parks & Recreation Master Plan. He is also working on a Transportation Master Plan.

- B. 2nd Quarter 2024 Residential Building Permit and Lot Inventory Report Bird went over the charts in the packet. There were not any significant changes.
- C. Planning Conference Schedule
 Bird mentioned that those who showed interest in the upcoming conferences should have emails
 with the details. There is still time for the October conference, so if you didn't get signed up you still
 can.
- D. Upcoming Planning Commission Meeting Schedule and Work Sessions
