- H. BOARD REVIEW AND DISCUSSION/ACTION ITEMS
 - a. Vacant Position
 - i. No positions were filled, and no applications were received. The positions will be reposted with the two vacancies.
 - b. Liaison
 - i. Eric will be continuing to aid in the Town Liaison Position with Billy for the Parks and Recreation Advisory Board. This will encompass strengths throughout the Board in connection with the Town of Wellington staff.
 - c. Design Standards
 - i. Design standards were updated and presented. Members agreed that the standards were up-to-date and have no recommendations for change.
 - d. Wish List Items
 - i. Can the wish list be turned into a "Living" document for the PRAB members to work on collaboratively for the purpose of recommendation? This would be a great tool for the board members to have to work on in a consistent manner.
 - ii. There is a strong emphasis to use the PRAB board's priorities and wish lists to move forward with projects, volunteerism and large scale, achievable goals.

- iii. Big 3 items board members will dial in the most important projects that tie into the TOW strategic planning and accomplish at least 3 projects in 2023
 - Some ideas: bike fix stations, Viewpointe Park, fishing dock/pier, upgrading the skate park, basketball courts on the east side, giving more access to pickleball, getting volunteer help for these projects and finding funding
 - Volunteer work should be used in collaboration with pictures, documents and should be emphasized as a goal for the PRAB

e. Updates given to BOT Meeting

- i. The PRAB wants to present an update to the Board of Trustees on their progress, goals and vision
- ii. This should coordinate with the Parks and Rec update to the board and will be scheduled in the new year with help from Parks and Rec staff

f. Signage update

- i. Engineering was sent and we were told that signs would be ready to be done by this year. We don't have a date yet, but a physical sign should be in this year
- ii. Next step is to get the signs and finalize the places they are set

g. Bike Rack at the Library

i. Parks and Rec is working with PW to get a new bike rack and a spot for accessibility around the library

h. Memorial Area at WCP

- i. Parks and Recreation is working with Public Works to get full planning and the concrete idea to finish the project
- ii. It will go in at WCP and have drip line and have a volunteer presence there to help with planting and clean-up
- iii. Use of this space to recognize all military forces and their support

i. Recreation and Trails

- i. Bring in more importance to the "Recreation Piece" and how the Parks and Recreation Advisory Board is involved moving forward.
- ii. Thoughts, insight, and ideas that are documented are important when we get to these meetings to help us move forward
- iii. Trails will be a big focus as our community expands. Past plans were made and we need to re-invest into the thoughts and beliefs in the new year. This is a big priority for the board to work on moving forward
- iv. Any more trail info will be passed out and talked about in meetings to come
