Be it enacted by the Town of Wellington:

Ordinance Concerning the Regulation of Retail and Medical Marijuana Stores in the Town of Wellington

WHEREAS, in November 2021, Wellington voters approved initiative 2B by a margin of 1 vote, and WHEREAS, Wellington is divided on the issue; and WHEREAS, many voters did not vote because they thought the initiative would not pass.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF WELLINGTON, COLORADO OR THE REGISTERED ELECTORS OF THE TOWN OF WELLINGTON, COLORADO, THAT:

Section 1. Chapter 2, Article 14 of the Wellington Municipal Code is hereby repealed in its entirety.

Section 2. Chapter 2, Article 14 of the Wellington Municipal Code is hereby replaced and shall read as follows:

Article 14 - Retail and Medical Marijuana Establishments

Sec. 14-10 Prohibition

The operation of marijuana cultivation facilities, marijuana product manufacturing facilities, marijuana testing facilities, retail marijuana stores, and medical marijuana stores as defined by Colorado Law and Article XVIII of the Constitution of the State of Colorado be prohibited within the Town of Wellington.

Section 3. The Board of Trustees declares that, should any provision, section, paragraph, sentence or word of this Ordinance be rendered or declared invalid by any final court action in a court of competent jurisdiction or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences or words of this Ordinance as hereby adopted shall remain in full force and effect.

Section 4. All the provisions of the Wellington Municipal Code as heretofore adopted that are in conflict with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance.

Section 5. The Town Clerk shall certify the passage of this Ordinance and cause notice of its contents and passage to be published or posted. This Ordinance shall become effective immediately upon adoption or passage by the voters.
