All companies and individuals conducting business in Wellington must obtain a business license prior to operation.

The Town is excited to introduce business owners to Community Core, a web-based software the Town is utilizing to process business license applications.

Register today to begin the simplified online applications, streamlined reviews, and real time status updates for business owners.

TURNAROUND TIMES

A majority of business licenses are processed in 5 - 10 business days. However, some reviews may take up to 30 business days when additional information or coordination is needed.

ZONING INFORMATION

A friendly reminder from our Wellington Planning Department:

- Mobile vendors are allowed to set up on private property with the permission of the property owner.
- Locations of mobile vendors, vehicles, trailers or activities shall not obstruct any vehicular or pedestrian paths and shall not interfere with any ADA accessible route or parking.
